medmix Switzerland AG Wins Patent Infringement Case Against Wuhan Anscitech

medmix Switzerland AG today announced a favorable ruling in its patent infringement lawsuit against Wuhan Anscitech Farming Technology Co., Ltd. (科立博牧业 □ □ □ □ □), issued by the Wuhan Intermediate People's Court of Hubei Province, China.

The court found that Wuhan Anscitech had infringed medmix's Chinese invention patent No. 201010130055.6, titled "Middleware for Connecting Storage Containers to Static Mixers." The infringing products—mixing tubes sold under the "Anscitech" and "科立博" trademarks—were determined to fall within the scope of medmix's patent claims.

The judgment orders Wuhan Anscitech to:

- Immediately cease the production, sale, and offer for sale of the infringing mixing tube products.
- Pay for the direct damages to medmix Switzerland AG.
- Cover the legal and enforcement costs.

The court rejected Wuhan Anscitech's defenses, including claims of legitimate sourcing and non-infringement, citing clear evidence of manufacturing and marketing activities tied to the infringing products.

Hans Peter Brack, Head of IP Management at medmix, commented:

" This ruling reinforces our commitment to protecting our intellectual property globally. We appreciate the court's thorough examination and fair judgment, which sends a strong message against unauthorized use of patented technologies. medmix feels highly motivated and encouraged by this outcome to continue defending and strengthening our portfolio worldwide – confirming the effectiveness of our strategy to safeguard innovation."
